4. in the event the organizer agrees to a cancellation of the space contract. the Exhibitor will be liable for all, or part of the Contract price depending on when the cancelation request was received and acknowledged: if 90 days prior to the exhibition's opening date 50% OF Total amount if 30 days prior to the inhibitions opening date 100 of total amount if within 30 days prior to the exhibitions opening date more OF TOTAL Auburn the date of the cancellation request is the one on which the Organizers receive written notice by courier or far. And ac knowledge receipt of same to the Exhibitor, in addition to the cancellation charges, the Exhibitor will be liable for any specific consequent noun incurred on the Exhibitor •s behalf by the Organizers.
